The National Board of Examinations (NBE) proposes to grant Provisional Accreditation to the Department of Gastroenterology at Asian Instt Of Gastroenterology, Hyderabad (AP) for the period of three years w.e.f. January 2011 to December 2013 to provide PG training facilities to Three DNB candidate(s) each year in the specialty, subject to their fulfilling the following conditions:-

- a) <u>Duration of Accreditation</u>: Asian Instt of Gastroenterology, Hyderabad (AP) will be provisionally accredited by the NBE for the above specialty for a period of three years.
- b) Eligibility & Duration of Training: that, in super specialties, only those candidates who have passed the CET (SS) examination be trained, for a period of three years, against approved seats;
 - that, for Super Specialties courses, only those candidates who are in possession of a Post Graduate Degree, (recognized as per provision of IMC act/Government of India) will be trained for a period of three years, against approved seat(s).
 - ii) Centralized Entrance Test for entry to Super Specialty Programme

The entry to DNB Super Specialty courses is on the basis of a CET conducted by NBE & compliance of detailed guidelines notified by NBE. Details about the scheme of admissions are announced in the Information Bulletin, NBE Website and circulars issued form time to time by NBE. The hospital has to mandatorily comply with the scheme of admissions prescribed by NBE. It is the duty of the accredited hospital/institute to ensure that they refer to the information bulletin and circular(s) issued by NBE on the website of NBE www.natboard.edu.in; As per guidelines of NBE, there is no aptitude test, entrance etc. that can be conducted by hospitals for admission.

iii) Thesis for Post-doctoral DNB Super Specialty Candidates

All candidates registered for 3 years post-doctoral DNB Super Specialty Programme have to write a thesis as part of the Post-doctoral training. A copy of the duly approved thesis protocol must be sent to the NBE's office as per the protocol submission format. It is the duty of the hospital/institute administration to ensure that the candidates are provided with requisite academic support to complete their thesis protocol & thesis work. Both thesis works must be approved by an Ethical Committee constituted as per ICMR guidelines (www.icmr.nic.in).
